UAB LIETUVOS PARODŲ AND CONGRESŲ CENTRO "LITEXPO" INTERNATIONALPROCEDURE OF BEHAVIOR OF VISITORS OF THE EROTIC FESTIVAL "EROS" AND RULES

1. General provisions

1.1. Visitors to the UAB Lithuanian Exhibition and Congress Center "Litexpo" (hereinafter - Litexpo). behavior rules (further - rules) regulates main Litexpo, existing Freedom Ave. 5 Vilnius, visitor behavior Litexpo premises and/or in the territory, order.

2. General requirements for visitors:

- 2.1. Stick to it warnings signs, instructions or other links;
- 2.2. To personally take care of the health/life and property of yourself and other accompanying persons security;
- 2.3. Behavior yes that would not arise a threat to myself and to those around you, don't do damage, do not damage others visitors rights and interests;
- 2.4. Execute Litexpo administration, protection employees and/or others persons, authorized ensure safety and public order, instructions;
- 2.5. Immediately to inform Litexpo information center and/or protection employees about actions and/or circumstances that may/have caused damage to the visitor(s) or other persons health, life, property.

3. Visitors have the right to:

- 3.1. To Litexpo premises enter/exit only through specially for and equipped Litexpo inputs/outputs and only be in them during the Litexpo event/exhibition;
- 3.2. to get into to Litexpo ongoing events/exhibitions, in which the organizer determined for that real ones mandatory requirements (clothes code, age and etc.), only after submitting tickets and/or documents, granting the right to enter, and/or corresponding to the established requirements;
- 3.3. Electronic cigarettes and others tobacco products to smoke only specially for that intended and specially in marked places;
- 3.4. To use the changing rooms, cafes and other public facilities located in Litexpo according to the established procedure of use premises.

4. Visitors must to know that:

4.1. If entry to the event/exhibition is paid, every visitor to the event/exhibition can use only 1 (one) and the same ticket/invitation during one event/exhibition day. Get into event/exhibition possible only with tickets/invitations, purchased in the official sales in the channels online or in cash registers;

- 4.2. Visitors to the event/exhibition may be checked before entering the Litexpo premises protection employees. If event/exhibition during going on this inspection, visitor, wishing to enter Litexpo, he must allow himself to be searched, while checking his clothes, handbag and others things, which the security guard looks dangerous or posing a risk;
- 4.3. At that in case if ticket gives discount or special conditions for that really visitors category (e.g. seniors, students, people with disabilities, etc.), as well as when going to an event/exhibition are admitted persons from for that true age, protection an employee and/or the other serving the staff has the right to ask for an identity document together with the ticket, as well as a document, whose basis is provided discount visitor, having given up to submit those mentioned documents, him checking individuals can decide not allowed to event/exhibition;
- 4.4. Litexpo event/exhibition visitors and others persons must to carry out events/exhibitions organizer, safety services employees, of the police officers, and/or others security and order ensuring instructions of individuals;
- 4.5. Litexpo administration or other persons responsible or maintaining order in Litexpo premises, have right do not allow to Litexpo persons or them remove from Litexpo, if turns out that their available tickets, permits or other documents giving the right to enter Litexpo premises have been transferred or to sell individuals, those who do not have the right to use them;
- 4.6. In the event of unforeseen circumstances, in the event of danger or threat, the event/exhibition for safety or for execution, protection employee, of the police officer, Litexpo administration employee, and/or another Litexpo order overseer person requirement or by order of visitors to the event/exhibition may be transferred to places other than those specified in the ticket or asked to leave from Litexpo premises;
- 4.7. The visitor must have a ticket or other document giving the right to enter the Litexpo premises to protect until the end of the event/exhibition;
- 4.8. Due to security reasons Litexpo indoors is equipped video monitoring system, capturing visitors and their actions;
- 4.9. Every Litexpo visitor agrees that his voice and/or image will be used free of charge used during the live broadcast of the event, in the video of the event, information about the event in the spread, of the event in photos, accommodating them online or in another in public in space. This material, Litexpo event/exhibition organizer or third persons can to be is used unlimited the time in compliance with all laws of the Republic of Lithuania applicable to the use of this information. These rules apply in all at events, ongoing Litexpo premises/territories, which organizesLitexpo;
- 4.10. If the locker number is lost, the visitor must inform the locker room immediately personnel;
 - 4.11. For lost in the locker room a number the visitor must pay 10 Eur fee;

5. For visitors prohibited:

- 5.1. Enter paid events/exhibitions without tickets or other documents giving the rightto enter to the event/exhibition, if there is no another is provided entry to the event/exhibition order;
- 5.2. Without administration permit to enter on scenes, to behind the scenes and/or to events organizerof work places;
- 5.3. To use Litexpo Wi-Fi access network, having purpose to violate cybernetic security and/orhow otherwise commit a criminal act.

- 5.4. Without administration or others persons, responsible for the public one order, permit drive in toLitexpo internal territory.
- 5.5. Drive in by car or another transport tool to parking the site without payment for parking services;
- 5.5. Without separate Litexpo administration written permit organize but which ones ralliesmeetings and/or other similar events;
 - 5.6. Dangerously behave causing threat to myself and to others for visitors;
- 5.7. promote, to spread or distribute commercial/promotional content or harmful, aggressive, campaigning political, racist or religious nature material and information, including clothing;
 - 5.8. Organize signatures collection shares and/or execute anti-state agitation;
- 5.9. Humiliate event/exhibition participants and spectators with shouts, words and/or other actions human dignity and ignore behavior in public places norms;
- 5.10. To burn fire, allow fireworks, rocket, smoke powder, smoke bomb, a different one pyrotechnics, use flammable or explosive materials materials;
- 5.11. Possessing or carrying: cold weapons, firearms, or other dangerous items (e.g., umbrellas with sharp tips, etc.), explosive, flammable, chemical, or narcotic substances, as well as any other materials or tools that are prohibited or may pose a threat to the life or health of other people within the center's premises; any alcoholic beverages, as well as any other drinks or liquids, including glass, metal, or plastic containers;
 - 5.12. To spoil and to break Litexpo equipment, decoration elements, inventory and greenery;
- 5.13. Littering and/or polluting Litexpo premises, sanitary facilities (toilets intended for visitors etc.), in the territory.

6. Not allowed persons:

- 6.1. Not complying with Litexpo's rules, regulations and procedures, as well as public order, security, good ones moral provisions and requirements;
- 6.2. to the knowledge of the Litexpo administration and/or other persons supervising the procedure, committed or suspected having committed violations of public order, being punished for hooligan behavior, having committed or being suspected of having committed any which ones crimes or misdemeanors on Litexpo premises;
- 6.3. Those who do not meet the age requirements set by the event or exhibition organizers and/or their ownage does not substantiate with documents;
 - 6.4. Those who do not have valid of the event ticket or another to enter to the event allowing document;
- 6.5. Trying to event/exhibition to enter with already would use fake fake or in a different way invalid ticket or another right to enter to event/exhibition providing document, yes the same trying bring prohibited items into Litexpo;
 - 6.6. Intoxicated from alcoholic drinks, psychotropic and/or narcotics materials;
- 6.7. Own behavior raising threat Litexpo for safety, wealth, others visitors and/or their property for safety.

7. Final provisions:

7.1. For visitors, non-compliant these rules, Litexpo administration and/or others the public one The persons maintaining order in the Litexpo premises have the right to remove these persons from the Litexpo premises. In this one point specified basis from Litexpo premises removed to the

Persons, non-compliant these rules, to Litexpo can to be are not allowed or, for violations if it becomes clear or appears after entering the event/exhibition, remove it from the premises or territory of Litexpo without separate warning! Persons are responsible for violations of public order and Litexpo rulesin the acts according to the established procedure and conditions.
